OFFICIAL PRACTICE DAYS

July 19 - 21. **ALL COMPETITORS MUST BE OFF TOURNAMENT WATERS on July 22.** During official practice, competitors may only fish with other competitors per Rule 3ii.

PRE -TOURNAMENT OFF-LIMITS

Off-limits will begin on Sunday June 22 and extend through Saturday, July 19 @ safelight. During this time you are not allowed on tournament waters.

TOURNAMENT WATERS

Tournament waters will be Maryland waters ONLY of the Upper Chesapeake and all rivers, creeks and canals connecting to those waters. Only that water open to ALL public fishing will be considered tournament waters. Any waters closed to public fishing will be closed to this tournament's contestants. No boats allowed into the C and D canal. **The southern boundary will be the US Hwy 50 bridge.**

NOTE: Aberdeen Proving Grounds and all rivers, creeks and canals within the boundaries of Aberdeen Proving Grounds will be off limits to fishing. You will be allowed to drive through Aberdeen Proving Grounds when open.
