OFFICIAL PRACTICE DAYS	March 30 – April 1. ALL COMPETITORS MUST BE OFF TOURNAMENT WATERS on April 2. During official practice, competitors may only fish with other competitors per Rule 3ii.		
PRE -TOURNAMENT OFF-LIMITS	Off-limits will begin on Sunday March 2 and extend through Sunday March 30 @ safelight. During this time you are not allowed on tournament waters.		
TOURNAMENT WATERS	Norfork Lake and and all rivers, creeks and canals connecting to Norfork. Only water open to ALL public fishing will be considered tournament waters. Any waters closed to public fishing will be closed to this tournament's contestants.
