TOURNAMENT CHECK-IN / BRIEFING DATE	April 15, 2025 <b>REGISTRATION REMINDER:</b> All anglers must CHECK-IN in person with B.A.S.S. Staff onsite. This will be the only registration period. See Rule No. 4. <b>You will be fined for being late.</b>

OFFICIAL REGISTRATION / ON SITE CHECK-IN	9:00 am to 2:00 pm via Time slots. Onsite in person briefing and vessel electronic inspection will take place.		
TOURNAMENT BRIEFING	In person immediately following check-in		
OFFICIAL PRACTICE DAYS	April 12 - 14. <b>ALL COMPETITORS MUST BE OFF TOURNAMENT WATERS on April 15.</b> During official practice, competitors may only fish with other competitors per Rule 3ii.		
PRE -TOURNAMENT OFF-LIMITS	Off-limits will begin on Saturday, March 15 and extend through Saturday, April 12@ safelight. During this time you are not allowed on tournament waters.		
TOURNAMENT WATERS	The Tenn-Tom Waterway and all rivers, creeks and canals connecting to Tenn-Tom. Only water open to ALL public fishing will be considered tournament waters. Any waters closed to public fishing will be closed to this tournament's contestants. Locking is allowed and there will be a lock schedule provided		
	- Northern Boundary will be Hwy 30 bridge north of Bay Springs Lake		
	- Southern Boundary will be the Coffeeville Lock and Dam
